ADN 841: Nursing Seminar II Learning Unit 3: Handout Page 3 of 6 We need to give 3 L of NS over 24 hours Out tubing has a drop factor of 15 gtt/ml Now we need to change our 3 L to mL by moving our decimal point (3000 mL) and our time to minutes (24 hours = 1440 minutes) Plugging this into our formula gives us: $3000 \text{ mL} \times 15 \text{ gtt/mL} = 45,000$
